IV. Public Comment

- Jessica Hildebrand- discussed LEA moving in and out of hybrid and providing choice of models to parents.
- Karen Morfin- LEA is in virtual learning. Concerned about the lack of new assessments. Question as to how charters in our SELPA are addressing new assessments for students with IEPs and new needs.
- Sarah Dyroff- We are virtual but will try to see students that are really struggling with online learning one-on-one with them on campus.
- Lori Hahn- We just applied for a CDE mini grant for some additional funds for intervention materials and extra staff hours for 1:1 support for students.
- Norma Ming- Yu Ming is still in all-virtual, with a few students able to attend learning pods in-person at the school, where instruction is still provided online. One concern that I think would be helpful is understanding how to improve delivery of services remotely.
- Maya Scott-Chung- OSA- Daughter is in 11th grade, 504, has spent time trying to get assessment. Concerned about lack of assessment and implementation of IEPs- and legality of denying assessment due to distance learning.
- Jessica Hilderbrand- Regarding assessments: the SST process should still be in motion thus vetting up the assessment candidate students for assessment consideration. If the SST (interventions!!) process has not been implemented to fidelity due to Distance Learning, would it be appropriate to even consider for assessment without knowing how the student would truly respond to interventions if they were provided?
- Randi Pugh- LEA has managed to create a waiver for students to receive in person IEP services that has been in effect since early fall and there were some ESY services as well. Allowing parents to make decisions regarding in-person services.

- CAC Bylaws Update. Bylaws will be ready to review soon. Jessica Hilderbrand volunteered to review the bylaws when the draft is ready.
- PL Update. Between July to December- EDCOE Charter SELPA has provided professional learning opportunities to 2,891 educators statewide.
